***The Phoenix Papers* and FANS Conference**
AUTHOR AGREEMENT

The following is an agreement between _____, hereinafter referred to as the Author (if multiple authors, each must sign and submit a separate AUTHOR AGREEMENT and each will have the same restrictions and rights), and *The Phoenix Papers* and Fandom and Neomedia Studies (FANS) Association and Conference, hereinafter jointly referred to as the FANS, and governs

(title of work, which includes an article, essay, comment, book review, or other writing or graphic work created by the Author), hereinafter referred to as the Work.

1. Author's Grant of Rights

- a. Except as provided in Paragraphs 1(c) and 2(b), the Author grants to FANS the rights to reproduce and distribute the Work by FANS, in facsimile reprints or microforms, as a contribution to a collection published by FANS, and by means of an Internet or Intranet site over which FANS exercises effective control, and also by means of a third-party online legal information provider, such as, but not limited to, JSTOR and the FANS official website.
- b. FANS rights provided in Paragraph 1(a) shall be exclusive for a period beginning when this Agreement is executed and ending two (2) years after publication of the Work by FANS or two (2) years after execution of this Agreement, whichever is shorter, and shall be nonexclusive thereafter.
- c. FANS right to reproduce the Work includes the right to prepare a translation in any language or to authorize the preparation of such a translation, but such right is subject to the Author's approval of the translator, which is not to be unreasonably withheld.
- d. After the Work has been published by FANS, FANS shall have the right to authorize another party to reproduce and distribute the Work in the forms specified in Paragraph 1(a).
- e. The Author grants the above rights without claim of royalties or other compensation.

2. Author's Ownership of Copyright and Reservation of Rights

- a. The copyright in the Work shall remain with the Author.
- b. The Author retains the rights:
 - i. To reproduce and distribute the Work, and to authorize others to reproduce and distribute the Work, in any format, to students for classroom use, at or below cost;
 - ii. To include the Work, in whole or part, in another work of which the Author is the sole or joint author or editor, provided that in either circumstance the Author may not submit a work for publication that is substantially the same as the Work to another periodical without the permission of FANS sooner than two (2) years after publication of the Work or two (2) years after execution of this Agreement, whichever is

sooner, and provided further that such Work identifies the Author, and the FANS publication data.

- iii. To post the Work, in whole or in part, on an Internet or Intranet site over which the Author has effective control provided that such Work identifies the Author and the FANS publication data.
- iv. To reproduce, distribute, publicly perform, or publicly display the Work in any format for non-commercial purposes, and to authorize others to make non-commercial reproductions provided the Work is cited as being first published by FANS.
- v. FANS agrees to provide the Author an electronic copy of the Work in a format that preserves final page layout, formatting, and content with no technical restrictions or security settings to prevent copying or printing of the Work within fourteen (14) days of initial publication.

3. Publication by Others

FANS shall have the right to authorize another party to reproduce and distribute the Work in a form other than those specified in Paragraph 1(a), provided that such reproduction identifies the Author and the FANS publication data, and provided further that the Author has been notified by FANS of its intent to authorize such reproduction and distribution not less than thirty (30) days prior to the grant of such authorization and the Author has not within thirty (30) days after being notified given FANS written notice of the Author's objection to such reproduction and distribution.

4. Author's Warranties and Undertakings

- a. The Author warrants that to the best of the Author's knowledge:
 - i. The Author is the sole (joint) author of the Work and has the power to convey the rights granted in this Agreement;
 - ii. The Work has not previously been published, in whole or in part, except as follows (attach additional pages as needed):

 - iii. The Work does not infringe the copyright or property right of another; and
 - iv. The Work does not contain matter that is defamatory, violates another's civil right, right of privacy, right of publicity, or other legal right, or is otherwise unlawful.
- b. If the Work reproduces any textual or graphic material that is the property of another for which permission is required, the Author shall, if requested by FANS, obtain written consent to such reproduction.

5. Litigation

- a. If a claim is asserted against FANS as a result of the Author's alleged breach of this Agreement or the warranties herein, the Author shall be promptly notified. The Author shall have the right to participate in the FANS response to and defenses against such claim, and FANS shall not settle such claim without the

Author's approval. If a settlement requires FANS to make a money payment, or a money judgment is rendered against FANS, the author shall reimburse FANS for the amount of such payment or judgment, and shall pay the cost and expenses reasonably incurred by FANS in defending against the claim.

- b. FANS shall have the power, after giving notice to the Author, to initiate legal proceedings against persons or entities believed to be infringing the rights granted by the Author to FANS. The Author agrees to cooperate reasonably in the institution and maintenance of such proceedings. Damages recovered in such proceedings shall be applied first toward FANS reasonable costs and expenses incurred in the proceedings, and the balance shall be divided equally between the Author and FANS.

6. Editing and Printing

- a. The Author authorizes FANS to edit and revise the Work prior to publication by FANS, but the Work shall not be published by FANS unless it is acceptable in its final form to both the Author and FANS.
- b. The Author agrees to conform all prose and citations in the Work to the citation system defined in the most recent edition of the Chicago Manual of Style, or the APA Publication Manual, or the MLA Handbook, and that use will be consistent throughout the Work.

7. Final Agreement

This Agreement constitutes the sole agreement between the Author and FANS with respect to the publication and copyright of the Work. Any modifications of or additions to the terms of this Agreement shall be in writing. Faxed, scanned, or other electronic format copies of this document shall be treated as originals, including signatures.
